In accordance with Art. 21-23 of the Law on Employment and Insurance in the Case of Unemployment ("Official Gazette RS", no. 36/09, 88/10, 38/15, 113/17- other law, 113/17 and 49/21) and Art. 39 and 136 para 1 of the General Administrative Procedure Act ("Official Gazette RS", no. 18/2016 and 95/2018 - Authentic interpretation and 2/2023 - decision of the Constitutional Court), the minister of the Ministry of Labour, Employment, Veteran and Social Policy, acting based on an application of the company GLOBAL STAFF EMPLOYMENT DOO BEOGRAD, Partizanske avijacije 9, Belgrade, for determining the conditions of employment and issuing of an operating permit to an employment agency hereby adopts the following

DECISION

on the issuance of a permit for the performance of employment activities

1. The commercial entity GLOBAL STAFF EMPLOYMENT DOO BEOGRAD, with the seat in Belgrade, Partizanske avijacije number 9, registration number: 22005375, is hereby issued a permit to perform employment activities, namely: informing about employment opportunities and conditions, mediation in employment in the country and abroad, professional orientation and counselling about career planning and the implementation of certain measures of active employment policy in accordance with Article 20, para. 1, point 4 of the Law on Employment and Insurance in the Case of Unemployment.

2. The operating permit is issued for a period of five years from the date of adoption of this decision.

Rationale

On June 24, 2024, an application was submitted to the Ministry of Labour, Employment, Veteran and Social Policy by the commercial entity GLOBAL STAFF EMPLOYMENT DOO BEOGRAD, with the seat in Belgrade, Partizanske avijacije no. 9, for the issuance of a permit for the performance of employment activities.

Article 21 of the Law on Employment and Insurance in the Case of Unemployment prescribes that the agency's operating permit is issued by the ministry competent for employment if the conditions are met in terms of spatial and technical equipment and professional skills of the employees, and according to Article 25 of the Law, the operating permit for the agency is issued for a period of five years and can be extended.

In the procedure of resolving the submitted application, it was determined that the applicant, the commercial entity GLOBAL STAFF EMPLOYMENT DOO BEOGRAD, with the seat in Belgrade, Partizanske avijacije no. 9, meets the requirements to perform employment activities.

In consideration of the above, it was decided as in the enacting clause of the decision.



Instruction on legal remedy: No appeal is allowed against this decision. An administrative dispute may be filed with the Administrative Court, in Belgrade - Nemanjina no. 9, within 30 days from the date of delivery of this decision. The claim, together with the original or a copy of this decision, is to be submitted to the relevant court, directly, by registered mail, in the form of an electronic document, or it can be submitted on the court record.
