In accordance with Art. 39 and 136 of the General Administrative Procedure Act ("Official Gazette RS", no. 18/16 and 95/18 - Authentic interpretation), and in connection with Article 3 of the Law on Agency Employment ("Official Gazette RS", no. 86 /19), acting based on an application of the company **"GLOBAL STAFF EMPLOYMENT DOO BEOGRAD-NOVI BEOGRAD"** with the seat in Belgrade - New Belgrade, Partizanske avijacije 9, in the procedure for issuing an operating permit to a Temporary employment agency, the minister of the Ministry of Labour, Employment, Veteran and Social Policy, Nemanjina 22-26, Belgrade, in case number: 002417457 2024 13400 001 002 102 010, on 19.08.2024, adopted the following:

### DECISION

1. A temporary employment agency permit **IS ISSUED** to the company **"GLOBAL STAFF EMPLOYMENT DOO BEOGRAD-NOVI BEOGRAD"** with the seat in Belgrade - Novi Beograd, Partizanske avijacije 9, registration number 22005375, for the purpose of undertaking supplying of employees at the company seat, for a period of five years from the date of adoption of this decision.

2. The company referred to in point 1 of this decision **IS OBLIGED**, within eight days from the date of receipt of the Permit, to submit an application for registration of activity (78.20 Activities of agencies for temporary employment or other supplying of human resources 78.30 Other supplying of human resources) and business name where words "Temporary employment agency" will be indicated as the subject of its business.

3. The Company **MAY NOT** perform activities in accordance with this permit before the registration of activities as indicated in point 2 of this decision.

### Rationale

The company **"GLOBAL STAFF EMPLOYMENT DOO BEOGRAD-NOVI BEOGRAD"**, with the seat in Belgrade - Novi Beograd, Partizanske avijacije 9, submitted an application to the Ministry of Labour, Employment, Veteran and Social Policy, for an operating permit for a temporary employment agency on 14.08.2024.

In the process of resolving the submitted application, it was determined that the applicant meets the conditions prescribed in Article 3, para. 1 of the Law on Agency Employment.

The applicant undertakes, in accordance with Article 3, para. 2-4. of the Law on Agency Employment, within eight days from the date of receipt of the Permit, to submit an application for registration of activity (78.20 Activities of agencies for temporary employment or other supplying of human resources 78.30 Other supplying of human resources) and business name where words "Temporary employment agency" will be indicated as the subject of its business, otherwise it cannot perform the above mentioned activities.

In consideration of the above, it was decided as in the enacting clause of the decision.

**Instruction on legal remedy:** This decision is final in the administrative procedure and no appeal is allowed against it, but an administrative dispute can be initiated before the Administrative Court.

The claim will be submitted to the Administrative Court in Belgrade, Nemanjina 9, within 30 days from the date of delivery of the Decision.

A court fee in the amount of 390 dinars is due for a claim initiating an administrative dispute against this decision.
